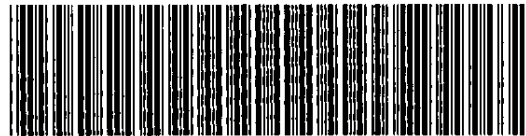

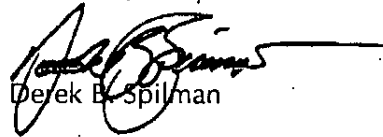

for

The name and Florida street address of the registered agent as previously designated and accepted in the Initial Articles of Organization is adopted, confirmed and continued by the Company without change or modification.

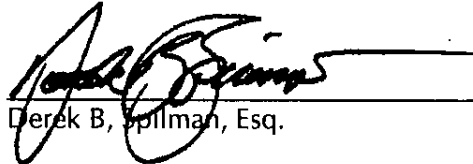
