ARTICLES OF ORGANIZATION

OF

MLBS, LLC

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608 (the "Act"), and pursuant to Florida Statutes §608.411 hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **MLBS, LLC** (hereinafter called "Company"). The principal place of business of the Company in Florida shall be in Brevard County.

The Company shall commence its existence on the date the original Articles of Organization were filed by the Florida Department of State, and the Company shall exist perpetually unless the Company is dissolved as provided by law or its operating agreement.

ARTICLE IV - PURPOSES AND POWER

The nature of the business and of the purposes to be conducted and promoted by the Company is to engage solely in the following activities:

1. To acquire by assignment from Wells Fargo Bank, N.A., as Trustee for the Registered Holders of J.P. Morgan Chase Commercial Mortgage Securities Corp., Commercial Mortgage Pass-Through Certificates, Series 2005-LDP4, a Commercial Note and Mortgage (the "Mortgage") recorded in O.R. Book 5788, Page 8442, all of the Public Records of Brevard County, Florida, and if elected by the Company, the real property, together with all improvements located thereon, secured by said Mortgage, located in the City of Melbourne, State of Florida (the "Property").

2. To own, hold, sell, assign, transfer, operate, lease, mortgage, pledge and otherwise deal with the Property.

3. To exercise all powers enumerated in the Act necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein.

Schippers, whose address is listed in Article II herein and who shall serve until he resigns or is otherwise removed according to the terms of the operating agreement.

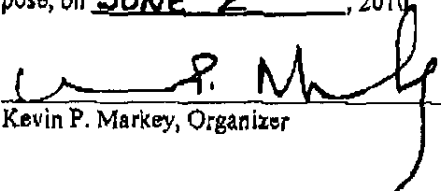
ARTICLE VII - AMENDMENT

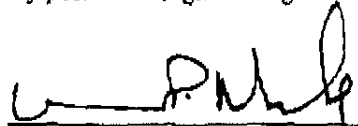
