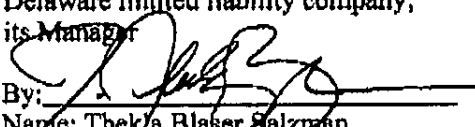
- FIRST:** The name of the limited liability company is CML-GA HWY I-85, LLC (the "Company").
