**SECOND RESTATEMENT AND AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
HIGHFIVE FROZEN YOGURT MT. DORA, LLC**

Pursuant to Chapter 608, *Florida Statutes* (the "Act"), the Articles of Organization of **HIGHFIVE FROZEN YOGURT MT. DORA, LLC**, a Florida limited liability company (the "Company"), filed with the Florida Secretary of State, Tallahassee, Florida, on June 7, 2010, under Document No. L10000060765, as amended August 10, 2010, are hereby restated and amended, effective September 17, 2010, as follows:

1. Articles I - V are hereby deleted in their entirety and the following new Articles I-V are adopted in their place and stead:

**ARTICLE I - NAME**
