**ARTICLES OF RESTATEMENT AND AMENDMENT TO
ARTICLES OF ORGANIZATION OF
HIGHFIVE FROZEN YOGURT HUNTER'S CREEK, LLC**

Pursuant to Chapter 608, *Florida Statutes* (the "Act"), the Articles of Organization of **HIGHFIVE FROZEN YOGURT HUNTER'S CREEK, LLC**, a Florida limited liability company (the "Company"), filed with the Florida Secretary of State, Tallahassee, Florida, on June 7, 2010 under Document No. L10000060811 are hereby restated and amended in their entirety, effective January 11, 2012 as follows:


1. Article I is hereby deleted in its entirety and the following new Articles I is adopted in the place and stead:

ARTICLE I - NAME

The name of the limited liability company is HIGHFIVE FROZEN YOGURT MOBILE, LLC (the "Company").
