**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
ARTISTRY AIRBRUSH FX, L.L.C.**

The undersigned authorized representative of a member of Artistry Airbrush FX, L.L.C., under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Amended and Restated Articles of Organization. The original Articles of Organization of Artistry Airbrush FX, L.L.C. were filed with the Florida Department of State on June 7, 2010. These Amended and Restated Articles of Organization have been duly adopted in accordance with the provisions of §605.0202, Florida Statutes, all members and managers of the Company having executed a Written Action, dated December 21, 2018, manifesting their intention that the Amended and Restated Articles of Organization be adopted.

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is St. Dufour Art Company, LLC (the "Company"). The Company's principal address and mailing address is 3910 Butternut Court, Brandon, Florida, 33511. The Company's registered agent is David M. Jeffries, whose address is 1227 N. Franklin Street, Tampa, Florida 33602. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

ARTICLE II

Duration of Existence

The Company shall remain in existence from the date the Articles of Organization are filed with the Florida Department of State until terminated in accordance with the provisions of the Florida Revised Limited Liability Company Act or the Company's Operating Agreement.

ARTICLE III

Management of the Company

The Company shall be managed in the manner set forth in the Company's Operating Agreement. 


