**ARTICLES OF ORGANIZATION  
OF**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Dunn, Salsano & Vergara Consulting, LLC (the "Company").
