ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF PANDORA OF MILLENIA, L.L.C.

Pursuant to the provisions of Section 605.0202 of the Florida Statutes, the undersigned Florida Limited Liability Company hereby adopts the following Articles of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the company is PANDORA OF MILLENIA, L.L.C. (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on June 10, 2010 as PANDORA OF MILLENIA, L.L.C. The Company's Florida document number is L10000062257.
