Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is 4138 Julington Creek Road, LLC (the "**LLC**").
2. The effective date of filing of the Articles of Organization of the LLC was June 10, 2010 (the "**Articles**").
3. The sole member of the LLC is G. Logan Rosborough III (the "**Member**").
4. The Member deems it to be in the best interest of the LLC to amend Article I to the Articles of the LLC.
5. That Article I of the Articles of the LLC is hereby amended in its entirety to read as follows:

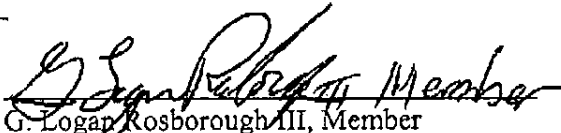
ARTICLE I
