ARTICLES OF ORGANIZATION OF BHTZ, LLC

The undersigned individual hereby adopts these Articles of Organization in order to form a limited liability company under Chapters 608, Florida Statutes.

ARTICLE I NAME

The name of the limited liability company is BHTZ, LLC (the "Company").

ARTICLE II EXISTENCE AND DURATION

This Company shall exist perpetually unless it is earlier dissolved as provided by these Articles of Organization, its Operating Agreement, or by operation of the Florida Limited Liability Company Act. The Company's existence shall commence on the date these Articles are executed, except that if these Articles are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, the Company's existence shall commence upon filing by the Department of State.

ARTICLE III PURPOSE

The Company is organized for the purpose of engaging in and transacting any lawful business permitted under the laws of the State of Florida and shall have the power to do any and all acts necessary, appropriate, or incidental to such purpose.
