**ARTICLES OF ORGANIZATION
OF
PREMIER TITLE AGENCY, LLC**

**ARTICLE I
Name**

The name of this limited liability company is **PREMIER TITLE AGENCY, LLC.**

**ARTICLE II
Existence**

This limited liability company shall have perpetual existence.

**ARTICLE III
Purpose**

This limited liability company is created for any lawful purpose (except that special statutes for the regulation and control of specific types of businesses shall control when in conflict herewith) and for the benefit of its members and such business as may be agreed on by its members.

**ARTICLE IV
Registered Agent and Address**

The mailing and street address of the principal office of the limited liability company shall be 3309 W.
