

The undersigned, PHILIP E. PERREY, desires to form a single member limited liability company pursuant to the Florida Limited Liability Company Act. As an authorized representative of the sole member of the proposed limited liability company, he does hereby make and file these Articles of Organization, and hereby declares and affirms:

ARTICLE I: Name
