**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, hereby adopts the following Articles of Organization.

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is TREBY LAW FIRM, LLC, and its principal office and mailing address is 695 Central Avenue, Suite 270, St. Petersburg, Florida 33701.

ARTICLE 2: MEMBERS RIGHTS TO CONTINUE BUSINESS

This Company shall exist perpetually, commencing as of the date of acceptance and filing of the Articles by the Secretary of State of the State of Florida.

ARTICLE 3: PURPOSE

ARTICLE 6: ADMISSION OF ADDITIONAL MEMBERS

The power to adopt, alter, amend or repeal the Operating Agreement of this Limited Liability Company shall be vested in the Members of the Limited Liability Company.


ARTICLE 8: TRANSFERABILITY OF MEMBER'S INTEREST

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which that Member otherwise would be entitled.

ARTICLE 9: OPERATING AGREEMENT

The members shall unanimously adopt the initial operating agreement. The power to alter, amend or repeal the operating agreement or adopt a new operating agreement is vested in members.


