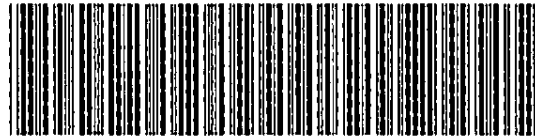

In accordance with Florida Statutes, Section 605.0202, the undersigned, being all the members and managers of this Company, adopt and file the following amendment to its Articles of Organization for the purpose of changing the form of the Company to a Florida professional limited liability company, to change the name and add a specific purpose of the Company accordingly, and to amend the name and address of the registered agent of the Company. The original Articles of Organization filed for this Company (Document No. L10000065141), shall remain in full force and effect to the extent that they are not amended by these Articles of Amendment to Articles of Organization.

ARTICLE I previously read as follows: "The name of the limited liability company (the "Company") is: SHREDERS & ASSOCIATES LLC." **ARTICLE I** shall be amended to read as follows: "The name of the Professional Limited Liability Company is: SHREDERS & ASSOCIATES PLLC."

ARTICLE III previously read as follows: "The name and street address of the initial registered agent of the company is Karly Shreders, 11040 River Point, Jacksonville, Florida 32223.", and the registered agent address was later amended to 12443 San Jose Boulevard, Suite 202, Jacksonville, Florida 32223, by a subsequent Reinstatement filing. **ARTICLE III** shall be amended to read as follows: "The name and street address of the registered agent of the company is Law Offices of Curtis & Associates, P.A., 701 Market Street, Unit 109, St. Augustine, Florida 32095."


ARTICLE VI shall be added to read as follows: "The specific purpose for which the Professional Limited Liability Company is organized is to engage in every phase and aspect of the business of rendering the same professional services to the public that either a licensed mental health counselor or licensed clinical social worker, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through

officers, employees and agents who are duly licensed under the laws of the State of Florida to render such services.

The professional limited liability company shall have all the powers conferred upon it by the laws of the State of Florida or of any other State or country and not prohibited by the Florida Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes, or the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes; provided, however, that this professional limited liability company shall not engage in any business other than rendering of the professional services described above for which it was organized.

It is expressly hereby provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this professional limited liability company otherwise permitted by law."

The undersigned has authorized and further certifies that all requisite company action by the members and managers sufficient for authorization and adoption of these Articles of Amendment has been taken effective January 10, 2019.
