**ARTICLES OF ORGANIZATION
OF
ELJASTOCK DIAMONDS, LLC**

The undersigned person(s), acting as Incorporator of ELJASTOCK DIAMONDS, LLC, hereby form a limited liability company under the Florida Limited Liability Company Act and adopt and certify as the Articles of Organization of such limited liability company the following:

I. NAME: The name of the limited liability company is:

II. TERM OF EXISTENCE:

This company shall have perpetual existence from the date of filing of these Articles of Organization with the Division of Corporations of the State of Florida.

III. PURPOSE:

The business purpose for which this limited liability company is organized includes, but is not limited to, the following:

The Company shall engage in the business of import and export manufacturing, wholesale, and retail.

In addition, the Company shall have unlimited power to engage and do any lawful act concerning any or all lawful businesses for which limited liability companies may be organized according to the laws of the State of Florida, excluding banking and insurance, including all powers and purposes now and hereafter permitted by law to a limited liability company.

V. CONTRACTING DEBTS:

Any member of the limited liability company, acting without the other members, shall be authorized to contract in all matters, including matters of debt, on behalf of the limited liability company. In addition, instruments and documents providing for the acquisition, mortgage or disposition of real or personal property of the limited liability company, shall be valid and binding upon the company if they are executed by one member of the limited liability company.

VI. OWNERSHIP:

The right, if given, of the members to admit additional members, and the terms and conditions of the admission:

Additional members may be submitted at such times and on such terms and conditions as all members may unanimously agree.

Ownership interest may be transferred only upon the prior approval of all members.

VII. MEMBERS RIGHT TO CONTINUE BUSINESS:

The remaining members of the limited liability company shall continue the business of the limited liability company upon the death, retirement, resignation, bankruptcy, expulsion or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

The Company is to be managed by its Managing Member (s).

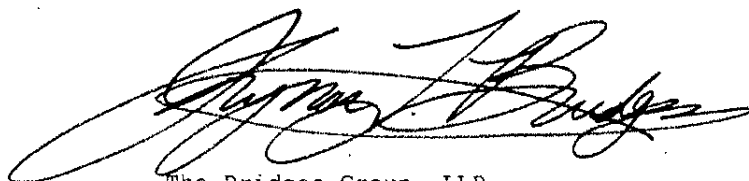
