Re: Statement of Fact – Prime LPI Business LLC (Document Number L10000065963)

Dear Division of Corporations:

DLA Piper LLP (US) has been retained by Prime LPI Business LLC ("Prime LPI" or the "Company") (Document Number L10000065963), and Daniel Correa, in his capacity as Sole Member of Prime LPI, to represent them in connection with filings made on behalf of the Company with the Division of Corporations through Sunbiz.org by former individuals associated with Prime LPI.

In particular, Mario Lacourt the former Sole Manager of the Company made the following false filings in which he wrongly identified himself as the Company's Manager:

- September 27, 2024 Annual Report
- November 27, 2024 Amended Annual Report
- December 2, 2024 Amended Annual Report

In each of these submissions Mr. Lacourt wrongly identified himself as the Sole Manager of Prime LPI and RDM Bookkeeping Service and Consulting Corp. ("RDM"), the President of which is Rosemary Marks, as Prime LPI's Registered Agent.

Mr. Correa is the sole member of the Company and is therefore authorized to act for the Company. On July 29, 2024, Mr. Lacourt entered into transactions as a result of which he assigned his entire interest in Prime LPI. As a result of these transactions, Mr. Lacourt's former interest was transferred to Mr. Correa. As Sole Member of Prime LPI, Mr. Correa removed Mr. Lacourt and appointed Dexter Dwight as the Sole Manager of the Company.

At all times listed and with regard to each of the three filings identified above, Mr. Lacourt was no longer a manager, member, registered agent, or otherwise authorized to act for or on behalf of Prime LPL

Concurrently with the filing of this request, Prime LPI and its authorized manager, Mr. Dwight, have filed an amendment correcting the Company's registration and also requested that the Company's Sunbiz.org account be frozen. Prime LPI also has demanded that Mr. Lacourt cease and desist from making any further false submissions with the Florida Division of Corporations and otherwise holding himself out as a person authorized to act for or on behalf of Prime LPI. Should Mr. Lacourt fail to comply, Prime LPI and its authorized representatives will seek a binding legal determination.

Nothing herein shall constitute a waiver, release, or otherwise by Prime LPI, Mr. Correa, or the Company's authorized representatives in connection with any claims or potential claims, including claims that may be discovered in our ongoing investigation of the conduct described herein. Prime LPI, Mr. Correa, and the Company's authorized representatives expressly reserve their rights to pursue any and all legal and equitable remedies available in connection with the actions mentioned above.
