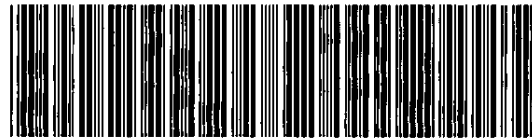



**ARTICLE I — Name:**

The name of the limited liability company (hereinafter referred to as the "Company") is "USA INSURORS, LLC."

**ARTICLE II — Address:**

The purposes for which this limited liability company is organized is to engage in any activity or business permitted under the laws of the United States and of this state.


**ARTICLE V — Limitation on Liability of Members:**




