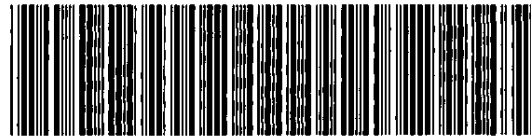



**Management**




**ARTICLE VII**
