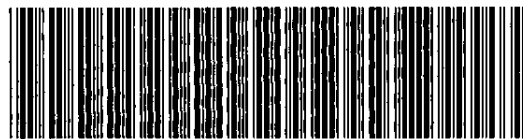

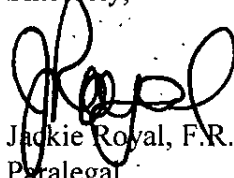

FIRST: The name of the Limited Liability Company is CARBONATE, LLC.

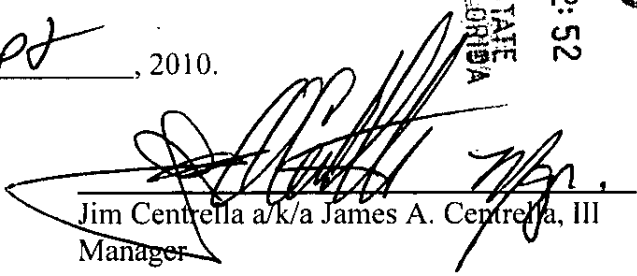
SECOND: The Articles of Organization were filed on June 22, 2010, and assigned document number L10000066390.

ARTICLE IV: Registered Agent: The registered agent's name shall be corrected to read James A. Centrella, III instead of Jim Centrella.

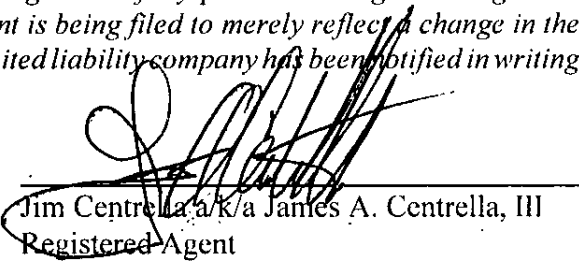
ARTICLE V: Members/Managers: The managing member's name shall be corrected to read James A. Centrella, III instead of Jim Centrella.
