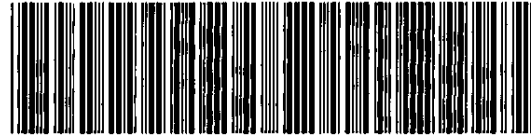

ARTICLE VI




