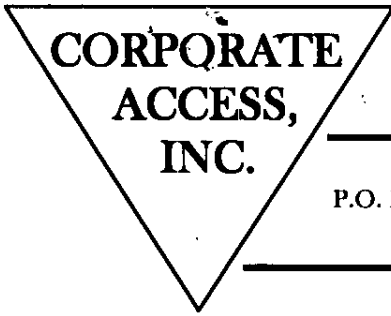

SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company by the action of its sole Member on November 18, 2010:


Article I of the Articles of Organization is hereby deleted in its entirety and is replaced by the following new Article I:
