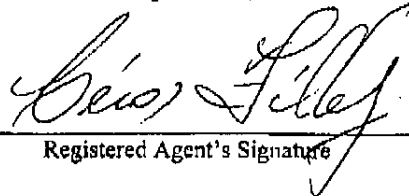

B- Management: The members hereby delegate the management of the LLC to Manager (s), subject to the limitations set out in this agreement.

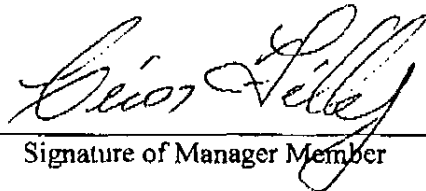
- 1) The Members shall elect and have the right to remove the Manager(s) by majority vote.
