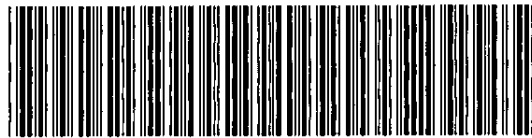

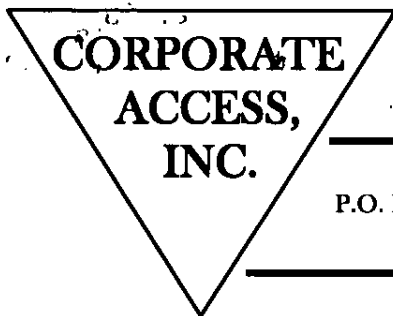



**ARTICLE II - PRINCIPAL OFFICE**




