To whom it may concern,

I was recently notified by an email from the "Division of Corporations" of its intent to administratively dissolve/revoke HAUGER PROPERTIES LLC L09000019852 and HEALTHCARE MANAGEMENT NETWORK LLC L10000070394 for failure to properly file the annual report.

At first I thought this was a scam or somebody trying to send me a virus because I knew I completed everything and put it on my charge card back in late April. When I received the second notice I decided to call your office and the representative I spoke to was able to find the filing then asked me to check my charge card to see if it showed the charges. It did not.

I had not thought to check my card to make sure the charge was applied because I have never had a case where it did not work.

Your representative advised me to write to you explaining my situation and enclose a check to cover the fees. She explained that trying to correct online would add the penalties that I should not incur automatically.
