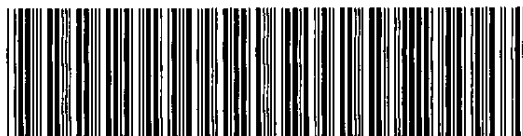


1. **Name:** The name of the limited liability company is **LAYER 2 SOLUTIONS, LLC**.
