The undersigned, acting as Organizers of a company under the Florida Company Act, hereby adopt the following Articles of Organization for such Company:

NAME: The name of this Organization is TCC, LLC.

DURATION: The period of duration of this Organization shall be perpetual.

PURPOSE: The purpose of this Organization is to engage in any activities or business permitted under the laws of Florida and California

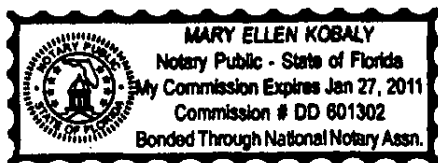


