As an authorized representative of the sole member of the proposed limited liability company, she does hereby make and file these Articles of Organization, and hereby declares and affirms:

ARTICLE I

ARTICLE VIII


The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely with the members of the Company.
