Operating Agreement

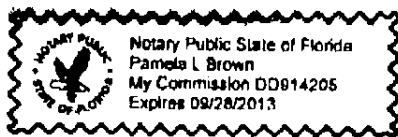


