ARTICLES OF ORGANIZATION

OF

A Florida Professional Limited Liability Company

ARTICLE I NAME

The name of this professional limited liability company is VASCULAR VEIN CENTER OF WATERFORD LAKES, PLLC, referred to in these Articles of Organization as the "Company."

ARTICLE II MAILING AND STREET ADDRESS

ARTICLE III COMMENCEMENT OF COMPANY'S EXISTENCE
