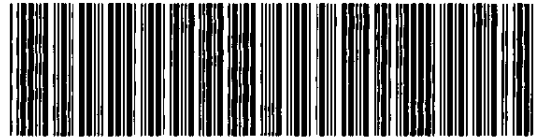

The street address and zip code of the principal executive office of the Company is: 90 Country Place, Cordova, Shelby County, Tennessee 38018.


**ARTICLE III. - COMPANY MAILING ADDRESS.**
