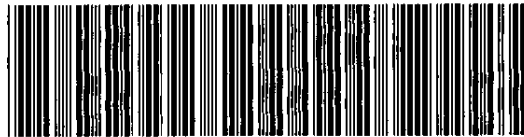

Pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

ARTICLE I
NAME

The name of this limited liability company (the "Company") shall be **FIVE CANONS, LLC**.

ARTICLE II
DURATION

Unless earlier terminated pursuant to the Act or the Operating Agreement of the Company, the period of duration of the Company shall be perpetual commencing on the date of filing of these Articles with the Florida Department of State.

ARTICLE III
ADDRESS

The mailing address and the street address of the principal office of this Company shall be 1825 A, 3rd Street North, Jacksonville Beach, Florida 32250.

ARTICLE IV
PURPOSE

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE V
REGISTERED AGENT

The initial registered office of this Company shall be 4241 Baymeadows Road, Suite 8, Jacksonville, Florida 32217, and its initial registered agent at such office shall be Brian Rowland, P.A.

ARTICLE VI
MANAGEMENT OF THE COMPANY

This Company will be a **member-managed** company managed by one or more of its members in accordance with and subject to the requirements of the Act and the operating agreement of this Company. The manager(s) may be designated as the president, secretary,

and treasurer of the Company, and may also be designated as vice presidents, assistant secretaries, and assistant treasurers, and shall have the authority normally associated with these positions under corporate law. The Company may also designate persons as directors under the Operating Agreement who shall act in a manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually, shall designate the manager(s), who shall also be members, and the positions that these managers will hold. No member(s), by mere virtue of his, her, its or their membership, shall have the power or authority to bind the Company to any agreement; to pledge, encumber or transfer any asset; or incur any debt, on behalf of the Company. **The initial manager shall be Justin Dennis.**

ARTICLE VII INDEMNIFICATION

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.

ARTICLE VIII CONTINUATION OF BUSINESS


On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

ARTICLE IX MEMBERSHIP AND INTEREST

Ownership in the Company shall be in the form of interest which shall be subject to transfer, membership and other restrictions; and additional terms and conditions, all as set forth in the operating agreement of the Company.




