THESE ARTICLES OF DISSOLUTION (these "Articles") of JJSA, LLC, a Florida limited liability company (the "Company"), are submitted as of this 5 day of June, 2018, in accordance with Section 605.0707 of the Florida Revised Limited Liability Company Act (the "Act").

The name of the limited liability company is: JJSA, LLC.

The Articles of Organization were filed on 07/12/2010 and assigned document number L10000073166.

The effective date of the dissolution of the Company shall be the date on which these Articles are accepted for filing by the Florida Department of State (the "Effective Date").

The occurrence that resulted in the Company's dissolution pursuant to Section 605.0701 of the Act was the occurrence specified in Section 605.0701(2) of the Act — the written consent of all of the members of the Company to dissolve the Company and wind up its affairs.

As of the Effective Date, the Company does not have any debts, obligations or liabilities. Accordingly, all debts, obligations, and liabilities of the Company have been paid or discharged within the meaning of Section 605.0711 and Section 605.0712 of the Act, or adequate provision has been made therefore pursuant to Section 605.0711 and Section 605.0712 of the Act.


In settling accounts after dissolution of the Company, the assets of the Company, if any, shall be distributed in the order contemplated by Section 605.0710 of the Act.
