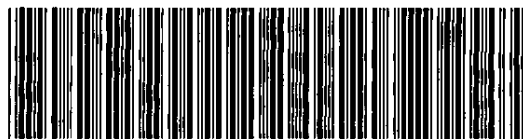

ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The company is organized for the purpose of consulting and assisting the 55 plus community to meet their life needs.




ARTICLE X – TERMINATION OF EXISTENCE




