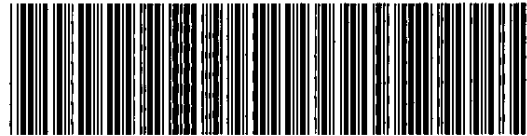

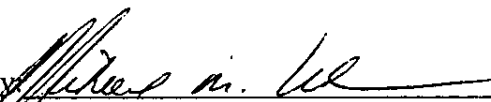

ARTICLES OF ORGANIZATION OF

BUMPER-TO-PROP, LLC

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be BUMPER-TO-PROP, LLC, and the mailing address and street address of its principal office shall be 3516 Shawnee Terrace, North Port, FL 34286, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II

PURPOSES AND POWERS
