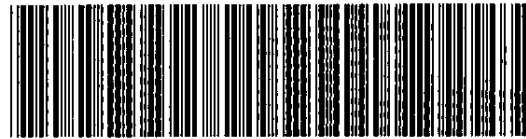

**ARTICLES OF ORGANIZATION OF
COOK REMEDIATION SERVICES, LLC**

(Pursuant to Section 608.407, Florida Statutes)

ARTICLE I - NAME

The name of the limited liability company is COOK REMEDIATION SERVICES, LLC.

ARTICLE II - ADDRESS

The mailing and street address of the company is 11 Feliz Avenue, Pensacola, Florida 32534.

ARTICLE III - PURPOSE

The company has been organized for commercial development and any other lawful business.

ARTICLE IV - INITIAL MEMBERS
