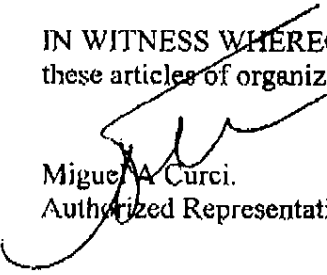
Article IX- Termination of Existence

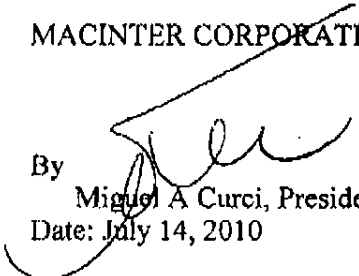
