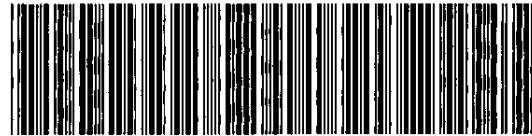



ARTICLES OF ORGANIZATION
of
TBM MANAGEMENT, LLC
A Florida Limited Liability Company

ARTICLE 1
NAME

The name of this limited liability company is TBM Management, LLC.




