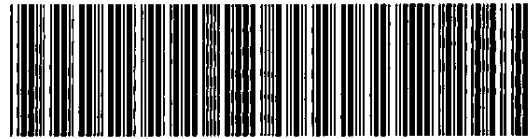



**Right to Continue**



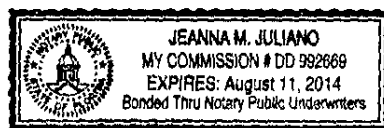
