ARTICLES OF ORGANIZATION

OF

BISHOPS COURT #2202, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Bishops Court #2202 TLC (the "Company"). The mailing address of the Company shall be 1063 Dunroven Drive Atlanta, Georgia 30342 and the street address of the Company shall be 13703 Richmond Park Drise, #2202, Jacksonville, Florida 32224.

ARTICLE II

ARTICLE V

TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

The managers shall be elected in the manner set forth in the Operating Agreement of the Company. DURATION AND COMMENCEMENT

The Company shall exist perpetually.
