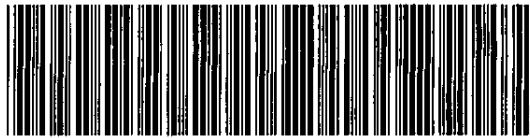

The name of the Limited Liability Company is SADDLEBROOK STABLES, LLC.

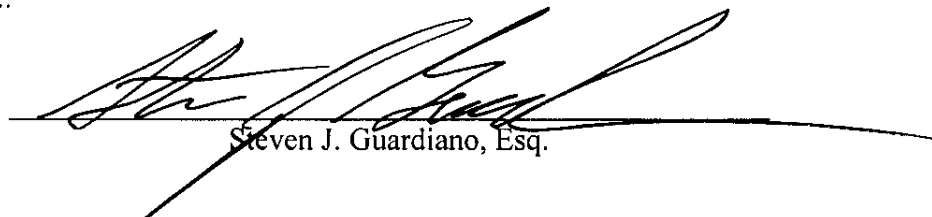
### ARTICLE II

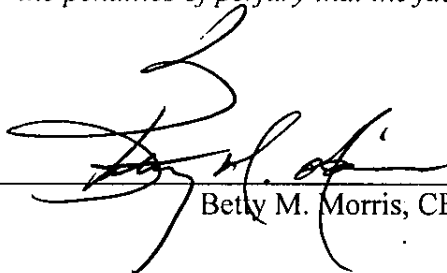
