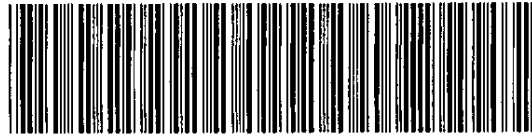


ARTICLE VII
