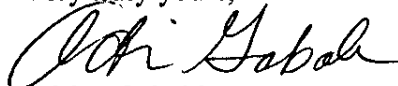

The undersigned natural persons hereby adopt the following Articles of Organization for the purpose of forming a limited liability company for profit under the laws of the State of Florida.

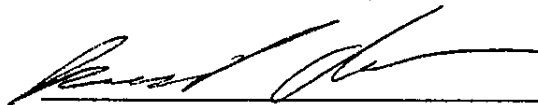
ARTICLE XII – BYLAW AMENDMENT

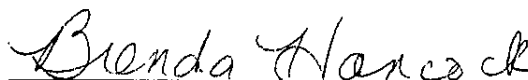

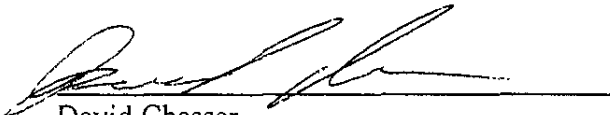
