The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to Florida Statute, Chapter 608, hereby certifies:

**ARTICLE I - NAME**

The name of the limited liability company shall be Leech LLC, hereinafter referred to as the "Company".

**ARTICLE II - ADDRESS**

The principal street address and mailing address of the Company is 175 SW 7<sup>th</sup> Street, Suite 1519 Miami, Florida 33130.

**ARTICLE III - PURPOSE**

The Company is hereby organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

**ARTICLE IV - MANAGEMENT**

The Company shall be managed by one or more members, and therefore will be a member-managed company. **ARTICLE VI - DURATION**

The Company's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved by operation of law or: (i) in accordance with the Company's Operating

**ARTICLE VII - AMENDMENT**

These Articles may be amended only as provided by law or in accordance with the Company's Operating Agreement.
