**ARTICLES OF ORGANIZATION OF

The undersigned hereby executes and acknowledges the following Articles of Organization for the purpose of forming a limited liability company under Florida Statutes 621, the Professional Service Corporations and Limited Liability Company Act.

**Article I: Name of Limited Liability Company**

Article VII: Form of Management

7.1 *Indemnification*

(a) The company shall indemnify every manager, and the manager's heirs, executors and administrators, against expenses actually and reasonably incurred by the manager, as well as against any amount paid upon a judgment in connection with any action, suit, or other proceeding, civil or criminal, to which the manager may be made a party by reason of having been a manager of this limited liability company.

(b) This indemnification is being given because the manager(s) will be requested by the company to act for and on behalf of the company and for the company's benefit.

(c) This indemnification is not exclusive of other rights to which the manager(s) may be entitled.

(d) The manager(s) are entitled to the fullest indemnification allowed by the

current law or as the law may be amended after the adoption of these articles.

(e) A manager shall be liable to the company for the following actions:

- (1) Any breach of his or her duty of loyalty to the company, or to its members;
- (2) An act or omission that was taken in bad faith and which constitutes a breach of the Manager's duty to the company by an act that is grossly negligent, malicious, or intentional, as those terms are defined at law;
- (3) A transaction in which the manager benefits to the detriment of the company or its members.
- (4) An action for which the manager is liable at law and for which an indemnification is not allowed.

#### Article VIII: Purpose

Mean Giant, LLC has been formed for the following purposes: to develop internet business services, and to conduct or promote any lawful business or purpose permitted by the laws of Professional Service Corporations and Limited Liability Company Act.

#### Article IX: Right To Continue Business

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in Mean Giant, LLC, the remaining members have the right under the operating agreement to continue the business of Mean Giant, LLC.

#### Article X: Tax Treatment

Mean Giant, LLC is intended to be treated as a limited liability company for purposes of federal income taxation.

#### Article XI: Certificate of Membership

A member's interest in Mean Giant, LLC may be evidenced by a certificate of membership interest signed by the managing member, which may be assigned or

transferred. The right to assign or transfer a member's interest in Mean Giant, LLC is limited by the provisions set forth in the Operating Agreement.

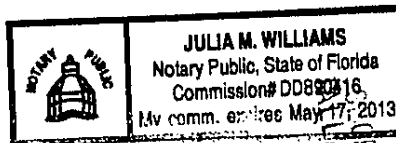
