ARTICLE VIII of the Articles of Organization relating to the management of the Company is hereby deleted in its entirety and replaced by the following:

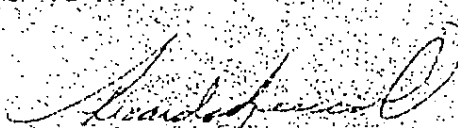
ARTICLE VIII - MANAGEMENT
