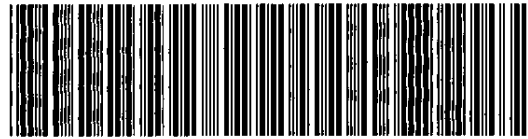



ARTICLE I

Name

The name of this limited liability company is SYLTBAR LLC (hereinafter "the Company").



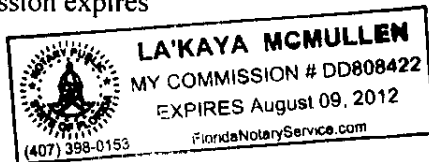
