ARTICLES X-INDEMNIFICATION

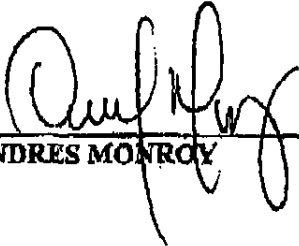
