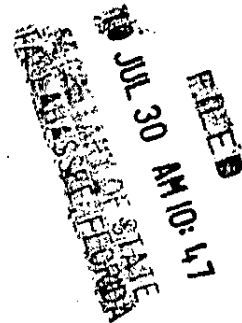
### Article IV. Transferability of Membership Interests

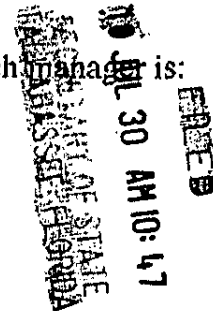
Article V. Distribution of Profits
