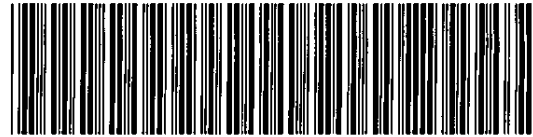




ARTICLE VI
