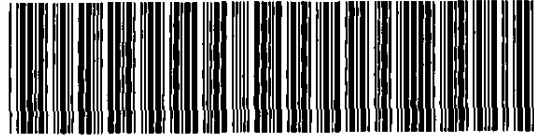

ARTICLE III - Purpose


The purpose for which this Limited Liability Company is organized is for any and all lawful business.


